

# Ведущий бизнес по производству хромовой руды

Компания входит в число лидеров №15 в Турции, специализируясь на производстве хромовой руды и концентрата. Это семейный бизнес. Благодаря благоприятному соотношению Cr/Fe и Mg/Al, турецкая хромовая руда пользуется большим спросом, особенно у Китая, ведущего импортера. Компания владеет тремя лицензионными участками и управляет двумя предприятиями по обогащению хрома, на которых работает 150 человек. Уровень запасов в настоящее время проверяется DMT Group, международной консалтинговой компанией.

На данный момент компания исследовала только 2% лицензионной территории. Ожидается, что к концу 2023 года отношение запасов к объему производства превысит 100 лет, что позволит создать предприятие по производству феррохрома, которое позволит выпускать продукт с большей добавленной стоимостью.

### Обзор рынка

Хромовая руда – это жизненно важный минерал, используемый в основном для производства феррохрома, важного ингредиента для изготовления нержавеющей стали. Мировой спрос на нержавеющую сталь, обусловленный такими отраслями, как строительство, автомобилестроение и производство потребительских товаров, оказывает значительное влияние на рынок хромовой руды. В конце 2023 года растущее внимание к экологичному строительству и распространение электромобилей еще больше повысят спрос на высококачественную нержавеющую сталь, что приведет к увеличению использования хромовой руды.
